Multnomah County launches SW 257th Safety Improvements Project

Multnomah County is leading an effort to improve the safety of the SW 257th Drive corridor

There isn't easy access to transit as well.

The \$6 million safety improvement project will include repaving SW 257th Drive between SW Cherry Park Road / SW Sturges Drive and SE Stark Street. Multnomah County will also be installing new lighting, improving accessibility at existing signalized intersections, constructing new curb ramps and removing barriers on sidewalks throughout the corridor. **Construction is expected to begin in spring 2024.**

SW 257th is one of the most heavily traveled Multnomah County roads in Troutdale, serving as a critical connection to I-84 and U.S. 26. Currently, it's difficult for pedestrians and cyclists to navigate the corridor. The sidewalks are partially blocked by utility poles and vegetation. Bike lanes are narrow and have little protection from traffic.

Don't Forget to Vote in the November 8 General Election!

There is still time to have your vote counted! Ballots can be mailed as long as they are postmarked on or before November 8, no postage necessary. Ballots can also be returned to an Official Ballot Drop Site no later than 8 p.m. on Election Day. Please visit www.Multco.Us/dropsites for a list of locations. In Troutdale, we have one located at the Multnomah County Library - Troutdale, 2451 SW Cherry Park Road. Please use the 24-hour book drop slot to deposit your ballot.

The project just wrapped up its first phase of outreach where Multnomah County looked to the community to play a major role in shaping this project. The County gathered input from those who drive, walk, bike or use a mobility device along the corridor, to help identify issues along SW 257th. In October, Multnomah County hosted two walking tours of the project site. This was an opportunity for elected leaders and the community to walk along the corridor with project leaders, get a general over view of the project and provide feed-

back on areas that need improvement.

In January, there will be another opportunity to weigh in on the project. Multnomah County will ask the community for input during another phase of outreach where the project team will present design options based on needs identified from the fall outreach. This feedback will be crucial in helping the County make decisions on what safety improvements will be constructed. Stay tuned for more details. For more information visit: Multco.Us/257th.

David oversaw a variety of transportation projects in Gresham, including plans to enhance walking and biking in Gresham as well as the city's 20-year blueprint for creating a balanced transportation system. That plan includes strategies to improve neighborhood connections and facilitate the movement of people and freight while giving motorists, pedestrians, and cyclists an equal opportunity to get around.

His goal is to help bring these kinds of opportunities to Troutdale.

“Everyone knows Troutdale has a great main street,” he says. “And with new opportunities at the Confluence Site and existing places outside of downtown like McMenamins Edgefield, Troutdale Station, and scenic areas along the historic highway, you have a place that is fantastic now, but also has so much untapped potential.”

The next step, he says, is “tying it all together to make an extraordinary place for Troutdale and East County.”

In addition to his work in Gresham, David has previously served as an urban design planner for the City of Hillsboro. He also ran his own urban design firm and worked as a planner and urban designer for some of Portland's most innovative architecture and planning firms.

David grew up on the East Coast before moving to the Bay Area as a teenager. He majored in environmental studies at UC Santa Barbara and earned a master's degree in urban planning at UCLA and a master's in architecture from the University of Oregon.

When not working, you might find David riding his bike along Historic Columbia River Highway, hiking with his dog, or playing golf – in his words – very badly.

Let's talk about abandoned vehicles - and leaves

The leaves are turning and starting to fall as we head into the equinox that begins winter. **Please do not blow leaves into the street.** Not only do we have an ordinance that prohibits it, but it blocks the storm drains which creates problems for our Public Works Department. Avoid flooding in your neighborhood. **Keep storm sewer outlets near your home free of debris and leaves.**

I would also like to encourage everyone to put away their campers and trailers and not store them on the street unless you are preparing to go camping or hunting. This includes “utility trailers” which cannot be stored on the street even if you leave them attached to your vehicle.

Parking continues to be the most frequent complaint, including vehicles that haven't moved in longer than 96 hours, parking in the wrong direction, blocking mailboxes, parking at a 90-degree angle to the curb in a cul de sac, etc.

The DMV IS OPEN! If you have expired or temporary tags, or no license plates, your car could get

tagged as an “Abandoned Vehicle” by definition:

TMC 10.04.020 - Abandoned vehicles. A vehicle that has been deserted, relinquished or has one or more of the following existing conditions: the vehicle license plate or registration sticker has expired or has been canceled; the vehicle has no license plate; the vehicle has no visible vehicle identification number (VIN); the vehicle appears to be inoperative or disabled; the vehicle appears to be unlawful to operate on a public street.

I would rather not write parking citations, however I do respond to all complaints. Thank you in advance for your cooperation.



When the Snow Hits the Streets

It may not come until January - or even February, but when winter weather strikes, the big question on everyone's mind is: will my street be plowed and sanded? To get your answer, go to: www.troutdaleoregon.gov/gis/page/interactive-web-maps and select “Snow and Ice Priority Routes”.

Major streets are cleared first as those serve the greatest number of users and are the most critical to mobility: 257th, Troutdale/Buxton, Stark, Cherry Park, Halsey, and Columbia River Highway are County maintained roads. But City crews will plow and sand county roads if the County's forces are occupied elsewhere.

Emergency Response and Public Facilities are cleared next, such as the Police Station, Fire Station, City Hall, and schools.

Collector streets, which provide connections to local streets come next. Among the collector streets are Beaver Creek Lane, Chapman Avenue, Corbeth Lane, Evans Avenue, Lewellyn Avenue, and Sweetbriar Lane.

Local streets are near the bottom of the priority list and, in most cases, warming temperatures and/or rain will remove the snow or ice before snow removal crews can get there.

Response time and crew deployments are determined by the storm's intensity. The City runs street crews when and where snow removal is needed. During larger snow and ice events, crews

work around the clock until the danger has passed and the streets are cleared to city standards.

Citizens can help by driving only if it's absolutely imperative right after a snow event. If driving is unavoidable, exercise caution, using all-wheel-drive vehicles or traction devices whenever necessary; this helps both travelers and city workers. The best thing that citizens can do to help everyone during storms and street clearing is to **park vehicles off the street**. Cars and trucks parked on the street during plowing operations pose a risk to both the public and plowing equipment.

The City cannot remove snow and snow piles from sidewalks and driveways, even after the snowplows come through. Nor can the city plow snow away from mailboxes. The city does not have the manpower to do that additional work, and by city ordinance, property owners or renters are responsible for clearing their own sidewalks and driveways.

We hope this gives you a good basic understanding of what happens during a snow or ice event, and we all hope for a nice uneventful winter!

The Environmental Protection Agency (EPA) would like to announce to the community that the Five-Year Review process has started for the **Reynolds Metals Company Superfund** site in Troutdale. A Five-Year Review is EPA's regular checkup on a Superfund site that has been cleaned up—but that still has some waste left behind. Five-Year Reviews ensure the cleanup continues to protect people and the environment. Soil cleanup was completed by 2006, which included removal of contaminated materials and demolition of the plant. A groundwater extraction system that cleans contaminated water is still operational, and regular groundwater sampling and monitoring continues. Recent analysis indicates that no unacceptable ecological risk is found in the Columbia and Sandy rivers from groundwater entering the surface water. An updated groundwater model of the site is being evaluated to determine if additional cleanup actions can be identified to enhance the cleanup of groundwater, which is primarily contaminated by fluoride. The former Reynolds Metals Company site has been redeveloped and is called the Troutdale Reynolds Industrial Park. IMPORTANT: Troutdale residents are allowed **three (3) free bulky waste items for drop-off**. To verify your Troutdale residency, please bring a recent WM statement. If you are a Troutdale resident who lives in a multifamily property without a WM statement, please bring a recent utility bill or other piece of mail with your address as proof of Troutdale residency. If you are not a Troutdale resident or bring more than the allowed three (3) free items, you will be charged accordingly. Items that do not meet WM's acceptable material criteria will not be accepted for drop-off.

QUESTIONS? Please contact Waste Management directly at 1-800-808-5901. If you would like to know if items you are parting with can be recycled, donated, or used, visit Metro's Find a Recycler webpage at www.oregonmetro.gov/findarecycler or call Metro at 503-234-3000.



Examples of Accepted Items:

- Small Appliances – microwave, toaster, blender, air fryer etc. not containing freon
- Large Appliances – washer, dryer, dishwasher, oven, range top, etc. not containing freon
- Outdoor/Garage Items – Grills without charcoal or propane tank, scrap metal, windows, drained water heater (1), bicycles, exercise equipment, file cabinet
- Household Items – Mattress, box spring, carpeting (with pad), furniture, sinks, toilets.

Not Accepted: Household garbage, animal waste, car batteries, engines, concrete, dirt, sod or stumps, food waste, household hazardous waste, liquids, paint, propane tanks, refrigerators (and other CFC/refrigerant containing items), rock, roofing materials, concrete.

This allows you to self-report a crime by filing a police report online without having to call the non-emergency phone number. 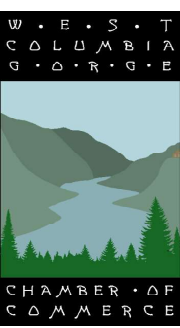
