Subject: Comprehensive Land Use Plan Overview

The Comprehensive Land Use Plan (often called the "Comp Plan") describes our vision and goals regarding the future growth and development of Troutdale. We also have several topic-specific plans referenced in the Comp Plan that go in to further detail on certain topics like transportation, housing, parks, and facilities. For example, the Transportation System Plan (TSP) that we are currently reviewing details our transportation goals and policies. By updating the Transportation System Plan, we are updating a piece of our Comp Plan as well.

The Comp Plan and topic-specific plans (like the TSP) present a big picture view of Troutdale's future. From the Comp Plan and topic-specific plans, we can draft and amend municipal code and development code to help implement this big picture vision.

In preparation for the January CAC meeting, please look over the resources on Troutdale's Comprehensive Land Use Plan <u>Webpage</u>. Also, please read the introduction and Goal 1 (pages 1-5 of the <u>Comp Plan</u>), Goal 12 (page 57), and skim the rest to get an idea for how the <u>Comp Plan</u> is organized and how the topic-specific plans fit in.

Subject: Transportation System Plan (TSP), Update Project

We will continue our discussion of the Transportation System Plan (TSP) and TSP update project at the January 2022 Citizens Advisory Committee (CAC) meeting. This project involves updating our current TSP which was written in 2014. We will aim to adopt an updated version in July 2022. The CAC will be the main group overseeing and providing feedback during the update process. Please refer to the table below (next page) for an overview of the update process timeline.

For this month, please continue reading the 2014 Transportation System Plan that was provided in print last month and is also linked below in the attachments. Specifically, please read the Executive Summary (chapter 1), familiarize yourself with the table of contents, and skim the rest of the report to get a feel for the 2014 Transportation System Plan. We will look more closely at chapters 3 and 4 in the coming months. Please note, we are reading through the 2014 TSP and no changes have been made to the version provided. As you read through the 2014 TSP, please note items you would like to see changed in the 2022 TSP.

Staff will be working with Kittelson and Associates to update the TSP. In February, Kittelson and Associates will draft "Memo #1" recommending changes to the "Existing Conditions" chapter (chapter 3 of the TSP). They will attend CAC in February to present on the existing conditions and request feedback. In April, Kittelson and Associates will draft "Memo #2" recommending changes to the "Future Needs and Improvements" chapter (chapter 4 of the TSP). They will attend CAC in April to present on chapter 4 and request feedback. In April, we will also discuss the transportation projects that are listed in the Town Center Plan (adopted May 2021) but have not yet been included in the TSP (most recently adopted in 2014).









