

Additional Information

- The property owner is responsible for the installation of new water, sewer, and storm service lines from the main to the end use, under permits issued by the City.
- Plumbing, fire, and/or public works permits are obtained through the Troutdale citizen self service portal (see Contact Information and Links section of this pamphlet).
- Property owners are responsible for maintaining the sidewalks abutting their property. A public works permit is needed to perform any construction on sidewalks in the public right-of-way.
- If you have any concerns about leaks or issues with your water meter, you can request a free leak detection test or water meter test from the public works department.
- For other utilities not addressed herein (power, gas, telecom, cable tv), check with the utility provider:
 - Power: PGE
 - Phone/Cable/Internet: Comcast or Ziplly
 - Natural Gas: NW Natural


Maintenance Responsibility



Permitting and Inspection Responsibility



Maintenance, Permitting, and Inspections for Commercial and Industrial Water Services



- For sewer and storm pipes, the city is only responsible for the main. The property owner is responsible for the entire lateral to and including its connection to the main.
- For water pipes, the city is responsible for everything from the main to and including the water meter. The property owner is responsible for everything from the water meter to the end use.

- For sewer and storm pipes, public works standards apply for permitting and inspections from the main to the property line. Plumbing code applies from the property line to the end use.
- For water pipes, public works standards apply from the main to and including the water meter. Plumbing code applies for permitting and inspections from the water meter to the end use.

- For fire service laterals, public works standards and permits apply from the main to the backflow protection vault. Fire and plumbing codes and permits apply from (and including) the vault to the end use. Public works maintains the fire line from the main to the vault. The property owner is responsible for the fire line from (and including) the vault to the end use.
